- Applicant fails to descriptively or adequately provide a real concrete method of assessment and data collection for
 the youth substance abuse problem in its specific community. The applicant notes the actual school district in
 which the coalition works does not have current 30day use or other Toth ATOD relevant data. The coalition is
 using data from a County level, which may or may not reflect the specific problems faced in its service area. More
 detail as to how the coalition plans to obtain coalition geographic specific data would have given this section a
 better score
- The coalition-building strategy in the applicant's planned approach does not include discussion of how this specific goal relates directly to a reduction in substance use by youth.
- Recruitment of youth that represents the community in which the coalition serves is not clearly defined. It does not describe if any targeted recruitment efforts will be made to ensure that participation is representative, i.e., race, ethnicity, socio-economic, etc.
- The applicant does not provide details as to how they will execute their strategies as it relates to strengthening the leadership of the coalition, assessing the capacity of the coalition and strengthening 12-Sector roles and responsibilities
- Applicant failed to include work history of a key staff member that includes a resume for verification of experience

^{*}The applicant does not provide details on the challenge of participation of the second largest school system that may impact their effectiveness on addressing youth substance use in the community
